Learning Objectives	Object of the course is the analysis of enforcement general rules, as described in the procedural civil code. This discipline represents an important phase of jurisdictional protection: the main purpose is to obtain the observance of the will of law and the material realization of the substantial rights. It constitutes a privileged observatory to study the relationships between substantial rights and the process itself. While the first part of the course is based on the analysis of the basic principles related to the concept of enforcement, the second part is centered on a more detailed study of the entire process related to the various enforcement proceedings.
Course prerequisites	It is recommended to take the civil procedure exam before taking the civil enforcement exam

Knowledge and understanding on:	Knowledge and understanding students will have the opportunity to learn the central themes of civil enforcement to protect subjective rights as well as individual civil proceedings for the implementation of the same. Autonomy of judgment: through the analysis of regulatory sources and the comment of case law, the student will be able to acquire flexibility, initiative, attitude to problem solving, critical problem assessment skills, and general capacity to draw up procedural documents. Communication skills: the student will be able to reelaborate and communicate with rigorous methodological information, ideas, problems and solutions related to all the topics of the course.
Applying knowledge and understanding on:	Ability to apply knowledge and understanding: through the continuous connection between theoretical notions and practical cases, the student will acquire an excellent knowledge of the application profiles of the subject developing a special method to allow him to identify the discipline applicable to individual cases

Learning skills: the student, addressing the topics covered by the course, will learn the systematic reconstruction of the theme of the protection of rights .
