Syllabus	
Content knowledge	Crisis and Transformation of the State in Europe, from the Seventies to nowadays.  The course deals with European history from 1945 on, and it will sketch the social and political conflicts arising from the so called globalization over the last fifty years. The focus will be on the crisis of political parties and on the shifting narratives of the past and the clashes of memories that cross the continent increasingly since 2004.  The course is stuctured in two parts:  1) Institutional part: deals synthetically with the relationship between State and international-supranational cooperation hinging around the institutions shaped by European la cooperation after 1945 and the changes occurred with the decline of the Cold war and the birth of the European Union;  2) Monographic part, which is not compulsory but voluntary for students attending 6 CFU, deals more in depth with the crisis of the mass parties and the rise of inequalities from the Seventies until today with special reference to Western Europe and the widening to the East of the EU.
