**TRAINING AGREEMENT**

(According to Art. 4, V° co., D.M. 25/3/1998, N. 142)

**BETWEEN**

The Department of Biosciences, Biotechnologies and Biopharmaceutics (DBBB) of the University of Bari located in Via Orabona n. 4, Bari, henceforth indicated as the “proponent”, represented by its Director, Prof. Luigi Palmieri

**Considering that**

to facilitate the professional choices through the direct knowledge of the working environment, the subjects, mentioned under Art. 18 (paragraph 1, letter a) in the law of 24/6/1997, n. 196, can promote training experiences in different organizations in favor of those who have already fulfilled their compulsory school obligations (under the law of 31/12/1962, n. 1859, as modified by the law of 20/1/1999, n. 9),

**The following is agreed:**

**Article 1**

According to article 18 of the law 24 June 1997, N. 196 and of the DM. 25 March 1998N. 142, the host is willing to accept **n x student** to accomplish a training period as proposed by the proponent according to article 11 of the D.L13 August 2011, N. 138

**Article. 2**

1. The training experience (art. 18, paragraph 1, letter d, of the law n. 196 of 1997) does not represent an employment relationship.
2. During the training period, the activity of the trainee is followed and verified by an academic tutor appointed by the proponent charged of supervising the overall development of the training, and by a training tutor appointed by the host directly involved in the training activity.
3. For each trainee accepted by the host, in accordance with this agreement, a training project should be prepared indicating:
  - the name of the trainee;
  - the names of the academic and host tutors;
  - the aims and modalities of the training with indication of working hours at host's structures;
  - the structures of the host institution (facilities, departments, offices) where the training will take place;

- the information concerning the insurance for civil liability and accidents.

### **Article 3**

During the training, the trainee has the following obligations:

- to accomplish the activities scheduled in the training project;
- to respect the rules of hygiene, safety and health at work;
- to maintain the privacy with respect to the results obtained during the training.

### **Article 4**

1. The proponent insures the trainee against accidents at the "National agency for insurance against accidents at work" (INAIL) as well as for civil liability at companies operating in the field. In case of accidents during the training, the host will report the event to the insurance institutions and to the proponent within time limits imposed by the law.
2. The proponent is committed, according to art. 5 M.D. 142/98, to send a copy of the agreement and of each training project to the region or province concerned, to the provincial structures of Ministry of Labor and Social Security competent for inspection as well as to the trade union representatives.

### **Article. 5**

The parties declare to agree that personal data and those issued by the activities of this agreement will be treated solely for the purpose of this agreement and anonymously for statistical analyses. Upon specific request, data can be made available to public and private parties only if the request will be compatible with their institutional activity. Owners of personal data will be The University of Bari and the host as identified in this agreement. Parties declare they are informed about rights enforced by article 13 of the law 675 of 31.12.1996 and subsequent modifications.

### **Article 6**

This agreement lasts 2 years from the date of its signature and can be renewed upon request of one of the parties.
